- 2) State Budget: ACT 15
  - What is in it?
    - \$110 million for the Child Care Bridge Payments (Child Care Counts Replacement)
      - Applications begin July 2026 ends June 2026
      - Any regulated provider is eligible
    - Community-based option for elementary school readiness
      - "Elementary school readiness program" means an instructional program that provides 4-year-old children with the social and cognitive skills to successfully transition to 5-year-old kindergarten in an elementary school setting.
      - Details on this program can be found here 49.132
    - Child care access program
      - Details on this program can be found here 49.1335
    - Child care center teacher-student ratio pilot project
      - Changes to definition of Infant and Toddler.
      - Ages 0-17mos 4:1 ratio will receive \$200/mo
      - Ages 18-24mos 7:1 ratio will receive \$100/mo
    - Not in the budget: Copay of no mor that 7% for families at 150% Federal Poverty Level. This is currently not in compliance with federal law.
  - What does this mean for Lincoln Co Providers?
    - Providers have continued state funding till June 2026
    - Providers are eligible to participate in the new Wisconsin Shares child care center teacher-student ratio pilot project. This is the new 18mo-24mo 7:1 ratio

    - Adopt A Provider was established by the Dream Up! Taskforce in Langlade and Lincoln Counties. This initiative aims to help area child care providers meet their individual needs by giving employers and community members a streamlined and tax deductible way to support.

      - 3CWI will write for a grant of \$10,000 for marketing for Adopt A Provider that will cover:

        - b. Childcaring (Platform Host)
        - c. Newspaper Ads
        - d. Info Session Night
        - e. Mailer Campaign
        - f. Supplies for provider to share with their parents
        - g. Possible collaboration with the Boys & Girls Club
